To what fate will we consign the Lacanian *letter*, the Lacanian *literal* or *littoral*, the Lacanian (*litera*-)*terra*, in our era, faced as we are with the recapitulation, intensification and acceleration of the metastatic crises he first identified in the Seventies?

We'll engage this year in a close reading of *Seminar XIX* (... or Worse) alongside 'The Knowledge of the Psychoanalyst,' comprising the lectures he gave that same year at Sainte Anne Hospital (a return after his 1963 'excommunication') as well as his published text *Lituraterre* in an attempt to sketch out, following the work of Néstor Braunstein, the *trans-Oedipal* clinical topos foreseen by Nietzsche and Sade—a *zone beyond good and* evil requiring 'yet another effort' by psychoanalysts on behalf of the *parlêtre* and in service of its *ethical destiny*.

Psychoanalytic Training in the School of Lacan - Part 4

[&]quot;The aim of my teaching has been and still is the training of analysts."

"The training of analysts is a subject that is well to the forefront of analytic research. Nevertheless—I have already given you evidence of this—in the analytic literature, its principles are lost sight of. - Jacques Lacan, Seminar XI

What does it take to train as a Lacanian psychoanalyst? Lacan's famous return to the truth of Freud is a major critique of what has gone terribly wrong with Psychoanalysis. Freud's students have deviated from the radical core of Freud's work and regressed to what Lacan had characterized many a time as a return to General Psychology. Lacan's return to Freud is nothing short of a proposal for an analytic training true to the spirit of the Unconscious, and ethics indicated by desire and later by the drive.

At the heart of this training, from one's personal analysis, control analysis, attending seminars, organizing and participating in cartels, teaching, la passe, and being involved in the activities of the School, is the question of whether or not one gets to finally assume the analytic position, the discourse of the analyst, and continuing to be involved in the many aspects of the transmission of the truth of Lacan and Freud.

It has been said, and Lacan said so himself, that most of his seminars, and his writing, are about training analysis.

This project involves not just the usual reading and familiarizing with Lacanian concepts—for example, the Imaginary, Symbolic and Real—but reading these categories to analyze how they guide and inform the training, technique, and practice of analysis. Therefore, we will go through the reading of Lacan's writing and seminars, from the early to the late Lacan.

This year-round seminar is designed to help candidates and precandidates as they traverse their singular journey to becoming Lacanian-Freudian psychoanalysts.

The Untreatable

Ever since Freud dreamt—and then wrote, in his *Interpretation of Dreams*—of Irma's injection, psychoanalysis has been propelled by a remainder. The dream marks a turning point in Freud's relation to his own desire: it marks his assumption of his own agency and *savoir* beyond the fall of the Other; and it constitutes an assumption of desire intimately and, we argue, necessarily, linked to what he sees ("a white patch and turbinal bones with scabs on them") when he looks down Irma's throat.

In this seminar, we are interested in exploring the "untreatable" and its role in the clinic, as well as links and differences between the concept of the untreatable, developed by Willy Apollon, and what Lacan conceptualized as the object-cause of desire. As Lacan argues in *Seminar XI*, "Analysis is not a matter of discovering in a particular case the differential feature of the theory, and in doing so believe that one is explaining why your daughter is silent—for the point at issue is to *get her to speak*, and this effect proceeds from a type of intervention that has nothing to do with a differential feature." Lacan makes clear here that the work of an analysis is not one of diagnosis, theory and identification, or explanation, but a work of speech.

What makes it possible, then, for any analysand to open her mouth and speak? How do we as clinicians act so as to provoke and sustain speech coming from the unconscious? What does the untreatable have to do with that risk, on the side of the analyst or clinician and on the side of analysand? What does the untreatable have to do with an analysand's assumption of her own agency, savoir, and desire? And what are the effects of framing a praxis around the untreatable for the clinics of femininity, perversion, and psychosis, in addition to the clinic of neurosis? We believe that our context involves unprecedented developments of world formation (mondialisation), that invite, and even compel, our consideration of such questions.

Cartel on Topology in the Lacanian Clinic

While our aim is to elucidate the theoretical basis upon which this link between psychoanalysis and mathematics (topology and graph theory) is fashioned, our specific concern is practical and clinical: what does such a mathematical framing of clinical material actually add or bring to analytic technique, and what does it actually enable or not enable us to do or conceptualize? Our exploration of the topology Lacan weaves into his theory promises yield conceptual clarity, clinical and—who insight, knows—mathematical delight?

Psychoanalysis and the Political

This seminar proposes to engage immediate political, civilizational, and individual questions and theoretical constructs in such a way as to ask, "What, if anything, can be done to transform society as we know it? We will trace the circuit(s) of drive and jouissance, as revealed in society, taking special note of the status of the Law with the assumption that while drive must find a place in the symbolic, so must jouissance be encountered/delimited. We will orient ourselves around the work of Cornelius Castoriadis as we explore crucial and immediate questions, especially those relating to threats of imminent civilizational and biospheric collapse.

What constitutes democracy? Is humanity capable of it?

Can the *act of the analyst* be deployed outside the clinic, in the political realm? What is it in the analyst that comes at the end of analysis? What is that way of being/experiencing, of knowing, of being with, that allows the analyst his *act*? What Lacanian names is it known by? Does something akin to it exist in registers other than, or come into the world through experiences other than, that of (Lacanian) analysis?

The Clinic of the Dream

In this seminar participants will present clinical sessions that include dreams. Following Freud and Lacan, we will consider the dream as a rupture of the unconscious from an Other scene, not as a narrative with a hidden meaning. The seminar will consider the field of the Other and the place of the analyst in guiding the analysand to hear the rupture of a dream and its signifiers through the fundamental rule of free association.

We invite participants to bring something close to verbatim sessions that include dreams and dream fragments. What rupture may have constructed the dream? What signifiers already present in the analysis did it evoke or elaborate? If there is a navel in the dream, what is the navel? If the dream is a nightmare, where was it interrupted? Is there a second navel created around the associations? What drives of the body may have been mobilized?

The case we are exploring here is not a case study of the patient, but the case of the-analyst-in training working under constraints of the Lacanian clinic and transference. We will ask presenters to speak about each time the analyst speaks or remains silent, and to explain these interventions in the unfolding

dream work. We will also ask for the subsequent session, including any new dream, so that we can learn something of the effects of the interventions.

Respecting the limits of language and the unknown unsayable that comes with dreams, we will listen to the presenter in the place of the analyst speaking to the logic that is at work in her or his interventions. The aim of the seminar is to develop a condensed 10-minute writing that highlights the dream logic.

As a condition of joining the seminar, everyone will sign a confidentiality agreement. Limited to 8 participants presenting, but others may join to learn about the clinic of the dream.

The Logic of Fantasy in the Direction Of the Treatment and the Analytic Act

This seminar approaches the question of the direction of the treatment in the psychoanalytic experience in terms of four logical moments of fantasy. In turn, the seminar is oriented by the question of the act, and especially the analyst's act within the frame of the analytic experience.

Just as Lacan's work leads us to work on the question of the direction of the treatment in the analytic experience, it in turn leads us to work on what Lacan

refers to as the "principle of its power." The seminar will consider the unique ways in which the analytic act takes a position in relation to this "power" mobilized in the address. The analytic act concerns a position oriented by analytic ethics, and the desire-to-know-of-the-analyst in the place of knowledge. This address welcomes a new and singular savoir (S2) that is on the side of the analysand insofar as the analysand is its subject (\$).

What is the nature of such an "act," and what is its relationship to the clinical experience of construction as regards the object of the fundamental fantasy and the creation of a new apparatus of jouissance in the form of sinthome? The seminar will orient these questions by reading and working from Lacan's Seminars XIV, *The Logic of Fantasy* and Seminar XV, *The Analytic Act*.

Lacan's Return to Freud

What is a case presentation? How does it differ from the presentation of a session? What is a note, taken in or after a session? What is it to speak to a Control or Supervising analyst about what was said, and what happened in a session? What is it to present the speech of the analysand session by session, and to take responsibility for one's act as an analyst in each session insofar as the analytic act of the Candidate-Analyst or Analyst welcomes the response of the unconscious within the constraints of the transference? What is the effect of the analytic act, and how do we create and sustain the session as a space and time for the work of the unconscious? These questions will inform our work in seminar on the question of the psychoanalytic clinic in the aftermath of Lacan's return to Freud.

As we work on ongoing clinical cases presented by the participants, the seminar will refer to the following readings: Chapter VII, "The Psychology of the Dream Processes" from Sigmund Freud's *Interpretation of Dreams*, "Notes upon a Case of Obsessional Neurosis," and the "Original Record of the Case, and Lacan's essay "The Direction of the Treatment and the Principle of its Power," and Willy Apollon's "What's At Stake in the Freudian Clinic" as we work on ongoing clinical cases.

The logic and experience of this seminar proposes and assumes a methodology and a praxis: our reading of Freud focuses on the ways in which Lacan's writing in the Écrits transmits a savoir that orients clinical practice insofar as it welcomes the dream, symptom and unconscious formations as they break through and from a censored unconscious. In addition, we will consider how advances made by recent approaches to working with dreams in the clinic of psychosis, addiction, and other disorders and discontents of the speaking being shifts our understanding and conceptualization of the transference as regards a real at work within the body and psyche of the subject in contemporary clinical practice.

Speech in Emptiness: A Theoretical and Clinical Discussion on Speech in Lacanian Psychoanalysis

In his Rome Discourse, Lacan reveals the important role that speech plays in psychoanalysis. Speaking about the speech is a way to hear what psychoanalysis truly speaks about or emptily cries out.

Desire and Jouissance are the central themes of psychoanalytic ethics. In this seminar, by following Lacan's footsteps, we will return to the discussion of "goodness" and "beauty" in the Western philosophical tradition, retrace Freud's concepts such as death impulse, the Thing, sublimation and etc. In this way, we explore the subject's desire in the topological structure and search for the source of jouissance under the radiance of Antigone's tragic beauty.

In clinical work, psychoanalytic discourse not only explores the content of the unconscious, but also profoundly affects subjective desires and intersubjective relationships at the level of structure. Therefore, ethics concerns every specific analyst and analysand in personal analysis, at the same time, it also represents a collective aspiration toward a profound glory sublimated above practice.

Transmission and the Lacanian School: From Television to Radiophonie and Beyond

Psychoanalysis is a social bond that constitutes a space for the work of the subject of the unconscious. In the aftermath of Lacan's invention of the Passe, the psychoanalytic School is a result of this bond that engages in the transmission of the *savoir*, or knowledge, of the unconscious. It stands or falls insofar as it sustains the guarantee of the lack in the Other and the defect of the signifier, and it is constructed and renewed on the basis of the work its adherents bring to transmit something of their experience within its frames (Palimpsest, seminar, teaching, cartel and reading group, Passage, and other forms).

Lacan's Television and Radiophonie raise questions regarding transmission in its relationship to psychoanalytic discourse and the speech of the subject of the unconscious. The analytic experience concerns the truth of the subject of the unconscious (S1) and the *savoir* of its subject (S2) that is constituted in its

experience and given place in the constitution of a new place in the social link through the act.

This event is an occasion for reflecting on the plethora of Lacanian emissions in today's contemporary media environment in order to better clarify and discern the ways in which the psychoanalytic School in the aftermath of Lacan's return to Freud functions as a frame for transmission in the formation of the analyst in our contemporary societies. It is an opportunity to work on the centrality speech takes in psychoanalytic transmission, and to the frames (the seminar, television, radio, podcast) that sustain it.
